Spotlight On

COMMUNITIES ENERGIZED FOR HEALTH (CEH)

Tehama County Residents Participate in Leadership Training!

Communities Energized for Health (CEH) organized a leadership training for Tehama County residents passionate about smokefree multiunit housing. The one-day training included presentations on the importance of smokefree housing, how to give public comment, and what the implementation process looks like once a policy is adopted. Time was also allocated for participants to begin crafting their public comment and to provide feedback to one another. Staff provided food, beverages, and gift card incentives to participants as a thank you for their time.

Tehama County is a rural county with 27 apartment complexes. CEH is currently working on jurisdictional MUH policies in both of the county's incorporated cities, Red Bluff and Corning, as part of our work plan. Of the 27 apartment complexes, 19 currently have voluntary policies, but a jurisdictional policy would protect all residents in the incorporated cities and ensure any new apartment complexes must be smokefree.

The highlight of the training was the activity where the participants had the chance to write their own public comments, incorporate their own story, relevant but brief data, and their ask. Everyone walked out of this training feeling, as the project's name suggests, energized for health.



Tobacco in the News

Comprehensive bans on sale of flavored tobacco products associated with less use of flavored tobacco without increasing nonflavored tobacco

More and more states and localities are enacting bans or restrictions on the sale of flavored tobacco products. David Timberlake and colleague recently published "Variation in adults' use of flavored tobacco products by sales restrictions in California jurisdictions" that uses data collected in California in 2019–2020 to show that comprehensive flavor sales bans are associated with 30% lower odds of adults consuming flavored tobacco products. There was no significant difference in the odds of adults consuming unflavored tobacco products.

There are three bottom lines from this study:

- Flavor bans reduce adult use of flavored tobacco products.
- There is not a compensating increase in adult use of non-flavored tobacco products.
- To be effective, the law has to be comprehensive.
- The study did not include youth.
